We believe that the application of these steps will contribute to the preservation and enhancement of the natural environment of New Zealand. Energy Efficiency

- Employ energy saving practices e.g. switching off computers.
- Use energy saving equipment e.g. light bulbs

Business Management

- Support local Sustainability initiatives e.g. the Nelson Tasman Sustainable Tourism Charter

Water Conservation

- Use water saving devices e.g. dual flush cisterns.
- Use water efficient equipment e.g. low volume, high velocity hose fittings
- NB. The charabanc uses tap water in its radiator

Health and Safety

- Manage the business practices in accordance with the Health and Safety Policy and Safe Driving Policy

Community Relations

- Donate time and use of vehicles to support community projects and organisations.
- Plan for charitable donations to ensure commitment and availability
- Purchase local goods and services and employ local people
- Help to actively support other local tourism related business e.g. collaborative marketing.

Supply Chain Management

- Review purchases of all goods and services giving preference and advising suppliers that preference will be shown to those that meet social and environmental criteria.
- Consider whole-life costs of purchases.
- Ensure suppliers can responsibly dispose of any waste products.

Contribution to Conservation

- Contribution and involvement with local conservations schemes.

Fuel Efficiency

- Regular fleet service and maintenance to ensure optimum fuel use e.g. tyre pressure, engine tuning.
- Consider fuel efficient improvements to fleet.
- Consider fuel efficiency and emissions of all future vehicle purchases
- Monitor fuel consumption
- Provide fuel saving tips to drivers

Chemicals & Hazardous Substances

- Ensure the correct use and storage of hazardous substances train staff in their use.
- Ensure spill prevention and clean up plans are in place and staff are trained in their implementation.
- Ensure chemicals are disposed of in an approved manner or through a registered and qualified agent.

Workplace Culture

- Involve staff in sustainability plans and encourage contribution and involvement.

Celebrate Success

- Promote awareness of the sustainability policy to staff and clients.
- Hold events for staff to share and recognise individual and business success.

Minimising Waste

- Consider an action plan - Avoid, Reduce, Reuse, Recycle, Compost – on all business waste.
- Set up systems for reuse, recycling and composting items e.g. paper, cartridges
- Reduce office waste – e.g. use both sides of paper.

Wastewater Management

- Ensure that maintenance and degreasing work is carried out by suppliers who responsibly and appropriately dispose of oils, hydrocarbons and waste water.

Environmental Education

- Provide staff and clients with information on the sustainability policy and on the Nelson Tasman Sustainable Tourism Charter and other schemes.
